SOLID WASTE MANAGEMENT

This Memorandum of Understanding is signed on 1st April 2024 (Monday) between Government Zawlnuam College, Zawlnuam, Mamit District, Mizoram- 796471, represented by Dr A. Jothi Associate Professor & Secretary Health and Sanitation Committee, Govt. Zawlnuam College hereafter called the FIRST PARTY

AND

Zawlnuam Town Sanitation Committee, Zawlnuam, Mizoram represented by Zorinsanga, Secretary, Zawlnuam Town Sanitation Committee hereafter called the SECOND PARTY

The MoU is intended to introduce proper waste disposal system in Govt. Zawlnuam College in collaboration with Zawlnuam Town Sanitation Committee which act as the waste disposal authority of Zawlnuam RD Block.

Whereas the Zawlnuam Town Sanitation Committee, Zawlnuam is the body in charge of collection and management of solid waste generated in Zawlnuam, through various local bodies under Zawlnuam RD Block agree to collect the solid waste generated by Govt. Zawlnuam college.

Whereas the Govt, Zawlnuam college agreed to give away the solid waste generated by the college as per prescheduled dates in every month.

Both the parties agree the following conditions

1. There will not be any financial claims from either side. Both parties agree to do the service and responsibility at free of cost. Any financial implications in the collection and disposal of waste will be borne by the respective parties and no fee or charges are made from either side.
2. The second party agree to collect the waste from the first party once in every month. The collection of waste will be done on last Saturday of every month and the first party will store/keep the waste at a single convenient point. Any inconveniences in this regard should be intimated to the second party well in advance.

3. At the time of collection of waste, representative from the first party should be present at the collection point.
4. The second party will intimate the time of waste collection in advance so that the representative of the first party will be available at the collection point. Any change in prescheduled dates should be informed in advance.
5. Once the waste is collected, the first party has no claim upon it and in no way it will be returned.
6. The local body responsible for collection of waste from the first party will be Vengpui Village Council Sanitation committee.

Entry in to force and Duration : The MoU will be in force from the date of agreement by both the parties and is valid for a period of three years unless cancelled by either of the party giving prior intimation and valid reasons..

IMPORTANT NOTE :- This MOU is subject to mutual agreement and understanding between the parties involved. It is not intended to be legally binding nor does it represent a contractual or commercial agreement between the parties.

The first party and the second party having read this document and agreement in full on this day of 1st April 2024 (Monday) have affixed their signature to work together in accordance with the MoU.
